

TELL A TAIL DOG TRAINING
COVID-19 & VARIANT – AFFIRMATION AND WAIVER

I acknowledge the contagious nature of the Coronavirus/COVID-19 and its variants. I understand that the CDC, State of California, and many other public health authorities still recommend practicing social distancing and that by voluntarily engaging in K9 Nose Work activities that I fully understand and acknowledge that I am increasing my dog's (The phrase "my dog" means the dog with which I am attending K9 Nose Work activities), my child's, and/or my risk to exposure to the Coronavirus/COVID-19, and variants thereof.

I affirm, represent and warrant that **I will not attend any Tell A Tail Dog Training K9 Nose Work activities if:**

- I am experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have traveled internationally within the last 14 days.
- I traveled to a highly impacted area within the United States of America in the last 14 days.
- I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19, or any variant thereof.
- I been diagnosed with Coronavirus/Covid-19, or any variant thereof; or I have been diagnosed with Coronavirus/Covid-19, or a variant thereof , but I have been cleared as non-contagious by state or local public health authorities.

I further agree to abide by and obey any and all Covid-19 & Variant risk mitigation procedures and protocols established by Tell a Tell Dog Training, LLC.

I acknowledge that Tell a Tail Dog Training, LLC cannot guarantee that my dog, myself, and/or my child will not become infected with the Coronavirus/Covid-19 or a variant thereof. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19, or a variant thereof, may result from the actions, omissions, or negligence of myself and others, including, but not limited to, staff, and other clients and/or their families.

I am voluntarily seeking services provided by Tell a Tail Dog Training, LLC. On behalf of my dog, my child, and/or myself, I do voluntarily elect to accept and solely assume all risks of injury incurred or suffered (a) while participating in K9 Nose Work Dog Training, (b) while competing at Tell a Tail Dog Training events and NACSW events, and/or (c) while on or upon the premises of the Facility and/or premises of other facilities utilized by Tell a Tail Dog Training.

I hereby release and agree to hold Tell a Tail Dog Training, LLC, Wendy Krehbiel, Gwen Marshall, Rena Thomason, and/or Carol Wilson, other instructors, and/or other Participants, the owner or operator of any field or indoor facility (collectively "Parties"), harmless from, and waive on behalf of myself, my dog, my children, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of Tell a Tail Dog Training, LLC, or that may otherwise arise in any way in connection with any services provided by Tell a Tail Dog Training, LLC.
